- All monies must be paid in full to the Breeder/Seller: Cindy Henderson before release of dog/puppy.
- The Seller reserves the right of first refusal or return of the dog/puppy in the event this buyer does not choose to keep this dog/puppy in the future, with no refund.

This dog is sold as a PET DOG BITCH under the following warranties and conditions and no other warranties or conditions either expressed or implied will take precedence. Pet definition is a companion animal purebred and AKC register able, that is sold as a pet with no warranty that the dog will be show quality or breeding stock and will be spayed/neutered at 24 months of age.

1. That the above animal is a purebred dog, register able with the AKC and that a registration application or individual registration has been given to the Buyer as of the date of purchase of the said dog.

- 2. That the above described animal may for any reason be returned to the Seller within 48 hours, along with the signed AKC papers, if applicable, at the time of receipt. Buyer shall assume full responsibility for the health, anatomical make-up, appearance and temperament of the above described animal during the 48 hour period. If the condition of the animal has changed in any of the categories mentioned in the previous sentence, the Seller is relieved of obligation to return the full amount of the purchase price. Otherwise the full purchase price less the non-refundable deposit of \$ \_\_\_\_\_\_ will be refunded. Any claim of change in the animal by the Seller must be communicated to the Buyer within 48 hours.
- 3. The parents of this puppy have had examinations done by both OFA and PennHip to establish that they are free of hip and elbow dysplasia. The Breeder/Seller guarantees the above dog/puppy to be healthy at the time of sale. The Breeder/Seller guarantees the above dog/puppy to be free of hereditary disorders, including hip/elbow dysplasia or degenerative myelopathy for a period of two years from the birth of the dog/puppy. If the dog/puppy is discovered to have any of the above disorders, a new dog/puppy will be freely given and the said dog/puppy will remain in his/her home. There will be NO monetary refund.
- 4. The Breeder/Seller does not assume any liability for injury or common canine ailments and/or diseases. The Buyer agrees to have this dog/puppy examined by a veterinarian within 48 hours of delivery. If the dog/puppy is found to be other than healthy by the Buyer's veterinarian, the Breeder/Seller shall be notified within 48 hours, the puppy returned to Breeder/Seller and the purchase price, less the non-refundable deposit of \$ \_\_\_\_\_\_ shall be refunded to the Buyer. Deadline date for refund is \_\_\_\_\_\_.
- 5. All appropriate shots for the dog's/puppy's age have been given, and a record of this vaccination history is supplied. Puppy shots are not 100% effective until their last shot has been given.
  - Do Not take puppies to pet stores, puppy classes or rest stops where other dogs have been until last shots are given. Be extremely careful with human and dog visitors till last shots are given as Parvo can be carried on clothing and shoes, it can also be air-born.

Puppy has also been dewormed. The Buyer agrees to maintain the dog/puppy's health in good condition, and to provide a yearly exam, and vaccinations at least once every three years.

- 6. The Buyer agrees to use a **top quality dog food** with NO fillers for the life of the dog/puppy. (Recommendations have been included in the Buyer's packet). Quality dog food is required for the healthiest dogs. PLEASE DO NOT OVER FEED! The Breeder/Seller recommends feeding a food or supplement with Glucosamine/Chondroitin after the dog's second year. The Breeder/Seller strongly recommends getting the dog/puppy micro-chipped.
- 7. We at AngelDay Shepherds have done everything in our power to breed and start healthy, happy, well adjusted puppies. The buyer has been given adequate information concerning the gluing of ears. Soft ears are not an indication of poor breeding, but an inherent characteristic of a dog with large, heavy ears. (Nutrition plays a huge role in proper ear development). There are many factors that can influence growth and development, such as diet, exercise, weight gain, etc. The Buyer assumes the responsibility to carry on the appropriate vaccinations, exercise and feeding schedule as was supplied by the Breeder/Seller. The Breeder/Seller can offer no further guarantees once the care of the puppy is no longer under our control.

## Socialization is critical to the dog/puppy's temperament development.

- 8. German Shepherd puppies should not be subject to extreme exercise at a young age, such as running with their owners, jumping over obstacles, or any type of strenuous exercise. As they are still growing and maturing this could really damage their growth system, causing lameness and limping. It is best to wait until 18 months to do vigorous type exercise.
- 9. Permanent ownership of this PET dog/puppy is contingent upon the compliance of the Buyer with this Spay/Neuter Contract. Proof of the spay/neuter must be received by the Breeder/Seller within 14 days after the surgery. This is the responsibility of the owner, not the veterinarian, to ensure that AngelDay Shepherds has received verification that the surgery has been preformed. Failure to comply with this agreement by the designated time will be considered a breach of Contract, and the Buyer will transport this dog/puppy back to AngelDay Shepherds and will not be entitled to a refund. By my signature below, I agree to have this dog/puppy spayed/neutered by no later than 24 months of age, and I understand that this

spay/neuter contract is an agreement that this dog/puppy will not produce a litter of puppies either as purposely bred or by accidental breeding. I also agree that should dog/puppy not be altered that I will return said dog/puppy to AngelDay Shepherds with NO refund.
